All prospective members must complete and submit a formal membership application, along with the non-refundable Application Fee. The Application Fee is applied towards your Initiation Fee, the balance of which is due upon the Board of Governors' acceptance of your membership.

Candidates for membership must be sponsored by two members in good standing of the Club. The Membership Committee can arrange to have you meet with members who would sponsor your application for membership if you do not have someone to sponsor you.

Upon receipt of your application, the Membership Committee will set up an interview with you to allow us to get to know more about you and to answer any questions you may have about the Club, its members, and its many amenities. After receiving the recommendation of the Membership Committee, your application will be submitted to the Board of Governors, where your membership will be voted upon. The Board of Governors meets on the second Tuesday of each month, and prospective members are encouraged to be present at the Club the evening that their membership is submitted to the Board.

Once elected to membership, you will be assigned a membership card, which will allow you use of the club's facilities, as well as provide you reciprocal privileges at other participating yacht clubs throughout the United States. You will also receive a key to the club, which you can use to access the clubhouse, yard, and facilities 24 hours a day, seven days a week.

Schedule of Annual Fees

Initiation Fee..... \$2,200.00

Includes \$200.00 non-refundable application fee due upon submission of application with balance due upon acceptance of membership by the Board of Governors. Corinthian membership exempt from initiation fee.

Annual Dues - Regular Members \$1,000.00

Dues are prorated and are billed quarterly

Annual Dues - Corinthian Members See Below

Ages 21 – 25 \$300.00

Ages 26 – 28 \$500.00

Ages 29 – 31 \$750.00

Ages 32 – 33 \$1,000.00

1/14th of each year's annual dues will be credited towards the initiation fee when the Corinthian Member transitions to full membership. A Corinthian Member who joins at the age of 21 will accumulate full credit for their initiation fee when they become a Regular Member at the age of 34.

Corinthian members enjoy all the benefits of full membership however they do not have a Galley/Bar minimum spend nor are they entitled to a vote.

Colgate Boat Share Program (Per Season)\$1,300.00

In-Water Slip Fee \$25 per foot

Galley/Bar Minimum Spend \$75.00/month

Total spend – not to include sales tax and gratuities

Annual Launch Fee..... \$750.00

Assessed to members who keep a boat in the mooring field. Launch fees are billed quarterly. Mooring acquisition and maintenance costs are separate and are the responsibility of the individual member. Contact Fleet Captain, Lou Rugulo.

Winter storage fees, locker fees, and other fees are billed according to rates established by the Board of Governors to those members utilizing the respective services.
